

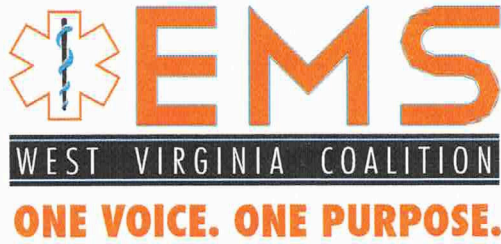
The Board of Directors of the West Virginia EMS Coalition would like to extend an invitation for your company to join our organization as an Associate member.
